The technical session on Human Resource Management was organized in two parallel sessions in Joseph's Hall and Seminar Hall from 12.15 pm to 1.45 pm. The session commenced with a welcome note from Mrs.R.Anita, Associate Professor, Department of Business Management and Dean Academics, that People are an organisations most valuable asset and the only source of lasting competitive advantage for business today. Everything else can be replicated such as products, services, infrastructure, but not people. She mentioned Alfred Sloan quotation who is the great leader of General Motors that "take my assets, leave my people and in five years I'll have it all back", is the basic tenet of organizational life which is heard time and again in corporate corridors. The guests were invited to chair the session. The Chairperson, Prof. B. Thrivikrama Rao was introduced to the gathering by Mrs.R.Anita, and Co-Chair persons, Prof.A. Suryanarayana and T. Muralidharan were introduced by Mrs. Sumitra Pujari, Assistant Professor, Department of Commerce.

Prof B. Thrivikrama Rao, Chairperson, addressed the delegates that HR plays an important role in an organisation and is an end to end process which starts from Selection, Recruitment to Retirement. He also stressed on the importance of innovation, use of new tools and techniques which a leader should adapt so that he has a better identity and position in the market. He also emphasized on adapting new teaching methodologies so that teaching is made learner friendly. Mr.T. Muralidharan, Co-Chairperson of the session emphasized on leadership and technology and also mentioned that, 'leaders are not made by looks but through the apt knowledge' and also stressed that teachers need to be informative, a good motivator and inspirer. Prof. Suryanarayana, Co-Chairperson mentioned that HR is the core of the organization which looks into work culture, change and functions of an organisation.

There was a Question Answer session which has given clarifications to the various queries raised by the delegates and participants. Prof.B.Thrivikrama Rao, the Chairperson has appreciated the participants who presented the papers with great enthusiasm. The Co-Chairperson, Mr. T.
