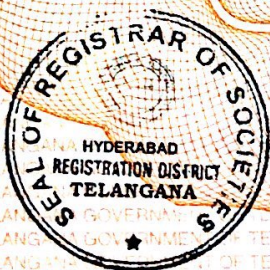

MEMORANDUM OF ASSOCIATION

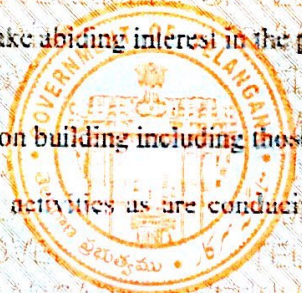
1. NAME OF THE SOCIETY : St. Joseph's PG Alumni Association (JOPA)

(ii) Category of members: General


(iii) Admission fee and the Annual Subscription or Monthly Subscription: 500 per Alumni
