This MoU, consisting of two pages, represents the entire and integrated agreement between the parties and supersedes all prior negotiations, representations, and agreements, whether written or oral.

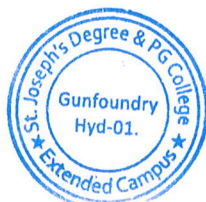
c) Severability:

e) **Regarding Changes in the Courses**




