The session started at 10:30am Mr.Sabir Saavant General Manager addressed the students and shared valuable insights into topics such as


- Basics of Investment

- Sebi Do's and Don'ts




The main objective behind the visit was to also explain about the important role that SEBI plays as the regulator and understand the dynamics of the Securities Market.


The feedback form was distributed to all the students and the analysis is as follows:

The students also extended their heartfelt thanks to SEBI for the valuable session.


How relevant was the content of the speaker


How interesting was the session
