SELF-RELIANT INDIA: A PATHWAY TO BEING DEVELOPED INDIA MISSION 2047

On August 15, 1947, India gained independence by overthrowing the British Empire. India was under British control for about 200 years. The Self-Reliant India Mission was introduced by Prime Minister Narendra Modi as the Aatmanirbhar Bharat Abhiyan. The goal of the Prime Minister is to make India self-sufficient. The promotion of regional goods is the primary goal of this endeavor. A special economic and comprehensive package totaling Rs. 20 lakh crores, or 10% of India's GDP in 2019-2020, was announced on May 12, 2020, in connection with the economic package linked to the coronavirus pandemic, with the goal of accomplishing this objective. Additionally, this mission is anticipated to support the "Make in India" program, which also promotes the idea that India does not need to shut itself off from or isolate itself from the rest of the world in order to be self-sufficient. It entails playing a larger and more significant role in the world economy.

The self-Reliant India plan, also known as the Aatmanirbhar Bharat Abhiyan, will be built upon five pillars: the economy, infrastructure, system, demography, and demand. The goal of this mission is to make all segments of India complexly self-sufficient in all areas, including education, health, agriculture, manufacturing, infrastructure, commerce, defense, foreign policy, and digital connectivity. Increasing the scope of private involvement in a number of sectors, changing the definition of MSMEs, increasing FDIs in the defense sector, and supporting solar energy are all crucial government decisions for the Aatamanirbhar Bharat Abhiyan.

The purpose of the Seminar is to bring together academics and researchers from various streams like Economics, Finance, the banking industry, startups, SHG's and organizations interested in topics for modifying the Indian economy and achieving a USD 5 Trillion economy. It will be assumed that discussions about how various stakeholder groups in the public and private sectors can work together as effectively as possible to jointly agree upon priorities for statistical studies that a strategy requires will be spurred by the top-level conference consultation.

It makes an effort to evaluate the constraints and present various recommendations for utilizing the current capability to become a global supplier and to determine the ability of some sectors to achieve self-reliance in order to identify the issues in the path to Atmanirbhar Bharat. In light of this, this conference will provide exposure to a variety of thematic areas with a focus on discussion and knowledge exchange among young faculty members, research scholars, and student communities in the social science discipline regarding the most recent trends and developments in their respective fields, as well as improving their capacity for highly regarded research and publication.

- The abstract must not exceed 250 words and six keywords. (Purpose, Design/methodology/approach, Findings, Originality) Use Times New Roman with 1.5 inch line spacing.
- A full paper should not exceed 6,000 words. (Introduction, review of literature, Data analysis/ discussion, Findings, Conclusion, Scope for further research) The Harvard style Emerald has adopted.
- A softcopy of the abstract and full paper in Word format may be sent as an e-mail attachment to sjcicssr2023@ josephspgcollege.ac.in with a plagiarism report.
- Authors can submit articles on Research papers, viewpoints, Technical papers, Conceptual papers, Case studies, Literature reviews, and General reviews.
