About the Program

The session was started by Prof.Anita, Convenor & Dean, Academics. Prof.Anita welcomed all the BBA Semester III Year V Students for the new Semester. She spoke about the importance of semester, general subjects & specially Specialization Subjects. Mam has elaborated on what are the characteristics that help choose Specialization. She has thrown light upon HR Subjects the Hr People create culture in the organizations apart from motivating the students. She Said V Semester the subjects are, HRD Systems and Strategies, Training and Development, Management of Employee Relations, Leadership Development and Change Management.



Talking about Leadership Management, she said Leader should have Emotional Intelligence to find solutions to the problems in crisis situations. Leaders have great significance I delegating the work and make the work happen. The students need to imbibe certain characteristics to become a successful Leader. By the end of the course the students will be able to understand the traits and personality of a leader in the Unit-I, In Unit II, the theories of leadership theories and styles will be dealt. Unit-III deals with leadership development succession planning and follower-ship. She said, in Unit IV, the students will be demonstrated the Corporate culture and it's relationship with leadership and in Unit-V deals with Women Leadership.

Second subject in Semester VI is Compensation Management. Prof. Anita Said, that this subject deals with introduction to compensation Management, Principles, role, trends and types of compensation, Unit II deals with compensation planning and bases of compensation, unit III ttalks about the benefits of compensation, Unit IV deals with designing compensation system and Unit V deals with contemporary compensation strategies.

The next Subject is 'Management of Employee Relations'. This course was oriented by Mrs.Gracy Saila Sree . She elaborated on the various Labour Laws that govern the organizations and protect the interests of the labour.

Dr. Rani Gujari, Spoke on HRD Systems and Strategies, Semester V. She said HRD is a more practical subject the course focuses on developing and understanding the skills, abilities and practical elements of employee development. She said, the students are first introduced to HRD and then they will learn analyzing HRD process. The students will be enlightened upon designing HRD programmes. The students will learn how HRD climate can be created and towards the ebed of the syllabus, the students will be taken through workforce diversity and learn how does it help the development of human resources.

Ms. Swapna, spoke on the course, Training and Development. She said, in present day scenario, we see lot of changes in the area of Training and Development.

Ms. Swapna also has spoken on the course, "Change Management". She asked students whether they would want any changes in the present scenario and substantiated it saying that change is inevitable. She

said this course enables the students to understand the concept of change management. This will help the students to emerge as leaders in the organizations.

She said in the unit I , the student will get introduced to change followed by understanding the change models in the unit II. In the Unit III, the students will be equipped with the knowledge of the impact of the change on the organization's people and processes. 


Mr. Martin oriented on "Customer relationship Management"


Mr. Martin concluded that people need to be upfront and dynamic to be in the field of Marketing and assured the students that students can approach the faculty anytime for any clarification.




Finance Orientation:




Prof. Vandana Samba oriented the students on the Finance Specialization.


Unit-I to V cover focuses on Introduction, RBI and Commercial Banks, Financial Institutions, Money Markets, Indian Capital Markets

Prof. Vandana Spoke on the courses, International Finance in Semester V and



Mr.Ganesh Anand oriented the students on the subjects, Investment Management in Semester V and Security Analysis and Portfolio Management in 6th semester.






Prof.R.Anita, Dean Academics explaining the Vision and Mission of the Department of Business Management



Insurance company size is usually measured by net premiums written, that is, premium revenues less amounts paid for reinsurance. There are three main insurance sectors: property/casualty, life/health and health insurance. Property/casualty (P/C) consists mainly of auto, home and commercial insurance. Life/health (L/H) consists mainly of life insurance and annuity products. Health insurance is offered by private health insurance companies and some L/H and P/C insurers, as well as by government programs such as Medicare.

The insurance industry safeguards the assets of its policyholders by transferring risk from an individual or business to an insurance company. Insurance companies act as financial intermediaries in that they invest the premiums they collect for providing this service. Insurance company size is usually measured by net premiums written, that is, premium revenues less amounts paid for reinsurance. There are three main insurance sectors: property/casualty, life/health and health insurance. Property/casualty (P/C) consists mainly of auto, home and commercial insurance. Life/health (L/H) consists mainly of life insurance and annuity products. Health insurance is offered by private health insurance companies and some L/H and P/C insurers, as well as by government programs such as Medicare.





Mam has addressed the forum by throwing light on NEP. Mam representing the NMSME has tried to emphasize on the facts that innovation should be encouraged at the college level as India has world's largest youth population standing second after china. It is predicted that India will enjoy the same predicament till 2040. India has commonly skilled people are at 2% compared to china 47% and US 52% which is very low. South Korea has the highest 96% skilled labor as per study done by Ruchira Agarwal, 2015.


According to Niti Ayog, it is estimated that 104 million students will enter labour market by 2020 and that our unemployment is a growing concern for the country. Unemployment was 12.9% for age group of age 18 to 25 in the year 2019 but due to the pandemic now it has doubled.

To curb this unemployment, India needs to create 150 million jobs by 2022. The country can create 75 million jobs by 2022, so an additional 40 million jobs should be created by 2022.

The jobless growth is a major concern and the demographic dividend is going waste so mam said there is a mismatch between education and jobs. Mam has emphasized that 58% of UG and 62% of PG are unemployed. The major reason for this being inadequate skills of the students. Mam has emphasized that the entrepreneurial skills are to be developed as it is the need of the hour.

Experiences of developing countries should be taken to improve the vocational skills. The need for creativity and innovation in students should be encouraged to get a decent innovation. In the global innovation index, India stands at 76 position in 142 countries, so we are very much lagging behind. National knowledge commission emphasized that entrepreneurial education should be encouraged.



Sir has stated that the four pillars that will enable the university to get the research projects are as follows: Academic leadership, Legal control, Organization capability, Entrepreneurial environment


