EXAMINATION REFORMS

AFTER AUTONOMY UPTO 2017

- 1. With the advent of Autonomy, the College introduced Semester pattern wherein the academic year is divided into two semesters.
- 2. Introduction of Evaluation Pattern consisting of two components, Continuous Internal Assessment (CIA) and End Semester Assessment (ESA) with 40:60 ratio for UG and PG.
- 3. Introduction of Skill Based Test (10 marks) includes presentations/seminars, creative assignments/mini projects.
- 4. Online publication of results
- 5. Introduced Grading system in evaluation in the place of Percentages and Marks after the introduction of CBCS as per UGC guidelines in 2015-16 onwards
- 6. From the 2015-2018 (CBCS batch) onwards credits of project evaluation is included in SGPA & CGPA onwards.
- 7. Instant examination is conducted for the students who have only one Backlog in Semester- VI in 2016-17 onwards.
- 8. Credits of Ability Enhancement Compulsory courses are included in the SGPA & CGPA from 2015-16 onwards.
- 9. Pass percentage is revised from 36% to 40% with the implementation of CBCS in 2015.
- 10. Double valuation in PG (Triple valuation is also done if the marks of first two valuations differ by 20% or more) from 2014 onwards.
- 11. A Mini Convocation is held in the same year, to award -Degree to the students upon their completion of the course successfully from 2014 onwards.
- 12. Consideration for sports students who participated and represented college in national / international sports events. (in reduction of pass percentage (30%).)
- 13. Scribe facilities (lesser qualified from other streams based on bonafide certificate given by the concerned college) and on request for students who are not able to write exams (because of injury/health grounds)
- 14. Concessions to Physically Challenged students minimum 40% of disability are implemented.
 - a. Exemption from paying the Examination fee for blind students
 - b. allowing excess time as per the norms
 - c. seating arrangement in the ground floor
 - d. wheel chair facilities
- 15. Squads are appointed to maintain strict & flawless system during conduct of Examinations
- 16. Backlog examination of Semester I& III will be conducted along with the main examination of Semesters I,III&V conducted in October/ November for those who have not completed 6 semesters study in the Collegeupto the academic year 2021.

Note: Students who have Completed 3 Years study are eligible to write backlogs only in Even Semester ie: in March/April

- 18. Online/ offline Student certificate verification from 2017 onwards
- 19. Online certification verification through Direct verify 'www.directverify.in' including WES (World Education Services) from 2020 onwards.
- 20. Generation of Computerized Exam application form and hall Ticket with all the details like Program name, Student name & HT No, Courses and Time table etc. from 2018-19.
- 21. Uploading the examination results and Grades on the college website immediately after the final exam result declaration from 2020 onwards.
- 22. Implementation of integrated software (.Net) of examination module with enhanced features from 2020 onwards.
- 23. Online Examinations and Evaluation during Pandemic using Hiremee Application in order to safeguard the health of students and faculty in 2020-2021 and 2021-2022.
- 24. Digitalized evaluation of answer scripts during A.Y.2020-2021 and 2021-2022.
- 25. Special Consideration was given to final year students who were affected by COVID to save their academic year.
- 26. Question paper setting as per BLOOM'S Taxonomy for MBA from 2020-21 and UG 202-23 onwards.
- 27. Question paper is thoroughly scrutinized to ensure the standard, spread of the syllabus and mapping of COs and following BLOOM'S taxonomy for MBA programme from 2020-21 and UG 202-23 onwards.
- 28. Backlog examination of Semester I& III will be conducted along with the main examination of Semesters II, IV &VI conducted in April/May for those who have not completed 6 semesters study in the College from 2021-2022.
- 29. Instant Examination will be conducted immediately after the result declaration for the current batch of students who failed in any one/two papers of the VI semester w.e.f 2021-2022
- 30. Compulsory Case Study Analysis introduced in the MBA internal and external question paper to assess the students' skills related to their thinking and problem-solving nature from 2020-21 onwards.
- 31. Inclusion of timings and date in the Hall ticket from the academic year 2023-2024 onwards.
- **32.** One time Chance examination for the batches 2011-2-13 to 2017-2020 in the academic year 2023-2024.
