Roles & Responsibilities:

The St. Joseph's Degree & PG College will provide space to conduct the training program in offline mode. The college will provide the infrastructure required for the course. Fees and Payment

The company is committed to providing support and guidance to help students achieve their career goals, and the placement process is designed to ensure the best possible match between students and potential employers.

This clause is an integral part of the overall agreement between the student and the Company and is subject to any additional terms and conditions outlined in the Company's policies and guidelines.

Intellectual Property Rights

The parties acknowledge that the course materials and instruction provided by the Company are the intellectual property of the Company. The College agrees to use the course materials and instruction solely for the purpose of delivering the Value Added Course to its students and

Termination

Either party may terminate this MOU upon 21 days' written notice to the other party.
