


Business News Club



The All-Elusive Women's Reservation Bill

India, for many centuries, prides itself as being a patriarchal society. Men have predominantly called the shots in all walks of life. The prevalence of it is also witnessed in the elective bodies of the country. The representation of women in the political scenario is minimal. Women comprise only 15% of all Lok Sabha seats and 14% of Rajya Sabha seats in the country. At present around 17 states have less than 10% women representatives. But the situation is not so bad in the local bodies of the country as 44.37% of women occupy prominent positions. As we go up the hierarchy ladder, the situation is worse: among the 29 states of the country, only one has a women Chief Minister. The Women's Reservation Bill aims to change the above.

In the year 1970 when the US questioned the Indian government on the progress on gender equality, a committee was set up and the findings seemed quite discouraging. A debate then had begun, and various suggestions were given as the country failed to ensure gender equality. In 1980 this proposal received political backing. When Mr. Rajiv Gandhi assumed office in 1987, he formed a committee again and received around 353 recommendations out of which one was the Women's Reservation Bill. In 1992 this proposal was partially implemented whereby 1/3rd of the seats was reserved for women in local bodies but the issue wasn't addressed for the elective bodies of the country. The then-serving PM Mr. Deva Gowda in 1996 went ahead and tabled the whole proposal

but failed to get any support as the OBC representatives vehemently opposed it. Since then, every PM has unsuccessfully tried to revive the

During the BJP's election campaigns of 2014 and 2019, one of its campaign proposals was the assurance of passing the Women's Reservation Bill. Finally, on the 20th of September 2023, the Lok Sabha successfully passed the bill with more than 2/3rd's

majority. The bill, "Nari Shakti Vandan Abhiniyam" reserved 1/3rd i.e., 33.33% of seats for women in all elective bodies of the country. This rule will apply to all legislatures. Accordingly, this quota of reservation will apply only to the Lok Sabha and not the Raiya Sabha, it will apply to state assemblies but not legislative councils. Passing of this bill was rejoiced by many but the possibility of it being made into a law is yet to be witnessed. This has caused an uproar among a lot of female activists and opposition parties, as well. The bill that's yet to become a law calls for 3 steps, the order being - census, delimitation, and then quota. The first step 'Census' was last taken in 2011 and the one that was to be taken in 2021 was delayed due to the pandemic and until now no date has been set by the government. Once the census is taken, the constituencies are redrawn, and the bill will be implemented. With many loopholes surrounding the census, speculation is rife that it's just a tactic of the current government to retain power. Hopefully, this is not the case, and the bill becomes a reality for the benefit of women in specific and society in general.

How Siddharth Lal saved Royal Enfield from going Bankrupt (II Prize) :

The iconic motorcycle brand in India, Royal Enfield, known for its classical design and thumping sound, was on the verge of bankruptcy in the late 1990s. However, Siddharth Lal, a young, determined entrepreneur, decided to step in and pull the company out of its losses, amidst the cutthroat competition with rival companies. Siddharth, who was only 26 years old at the time, made the company one of the leading sellers of two-wheelers in just two decades. It's quite remarkable how a budding entrepreneur was able to elevate the company, after being almost bankrupt in 1994, to one of India's most profitable automobile companies.

Royal Enfield was drowning

In the hectic competition of the 1990s, two-wheeler companies were touching the skies with their increased businesses in India. Royal Enfield also attempted to grab the opportunity by signing business deals with Madras Motors. The company began manufacturing motorcycles and operating in India after shutting down its business in the United Kingdom. As there was a heavy demand for motorcycles in the Indian market, companies including Yamaha, Jawa, and other Japanese firms followed and introduced sleek and fuel-efficient bikes at cheaper costs. The sudden introduction of these bikes almost collapsed Royal Enfield until it was sold out to a multinational automotive company, Eicher Motors. Later, they also wanted to shut down Royal Enfield because of the perpetual losses that it was making. However, Siddharth Lal, Eicher's CEO's son, decided to take over and resurrect the sinking ship in 2000.

One thing at a time

Siddharth Lal joined the company shortly after his graduation. He understood that the first step to elevating the company was to direct all the employees to ditch the company cars. He urged the employees to commute only on Enfield bikes. All this was done to recognise the issues that bikers come across and fix them. Moreover, Siddharth was also a firm believer in

"focusing on one thing at a time." So, despite having multiple businesses, he decided to prioritise only on bikes and trucks and close down all the other businesses. He had 15 different businesses, from ancillaries to garments, of which he closed down 13.

Creating a Cult

The last strategic execution was to build a cult around the bikes by focusing on the 'identity' aspects of the bikers through effective marketing. It included:

- · Sponsoring off-road rallies, adventurous rides, and rider clubs.
- Building classic retail outlets to enhance the buyer experience.
- · Building a social status around his bikes.

Today, whenever you hear the 'roary' and 'rumbling' motorcycle sounds, you know that it is a Royal Enfield ruling the streets. But, now that you know, it has not always been like that. The company not only possesses a huge fan base in India but commands a 30% market share in the United Kingdom as well. Royal Enfield won the award for the best marketing and sales, and today, it makes up to 90% of Eicher Motors' profits.


